At the extraordinary general meeting held on 12 January 2026, the shareholders approved (i) the extension of the maturity date of the HK\$89,840,000 convertible bonds from 12 January 2026 to 12 January 2029; (ii) the adjustment of the interest rate of such convertible bonds; (iii) the change of the conversion price from HK\$0.32 per share to HK\$0.28 per share; and (iv) the increase in the number of conversion shares from 280,750,000 shares to 320,857,142 shares.
